# *Justice* for **ANIMALS IN RODEO**

### The New Zealand Animal Law Association and SAFE have teamed up again

This time we're taking the Minister of Agriculture and the National Animal Welfare Advisory Committee (NAWAC) to the High Court to seek justice for animals abused in rodeo.

In July, we filed a legal challenge with the High Court stating that rodeo events are in violation of the Animal Welfare Act 1999. With your support we are again able to call for an end to the abuse of animals in the strongest way possible - through a complete, legal ban.

You've stood with SAFE for many years as we've spoken out against the suffering caused to animals forced to perform in rodeos. You've been with us at the protests. You've contacted your MP. You've written to the Prime Minister and the Minister of Agriculture asking that they ban the roping of baby animals and use of painful spurs for the entertainment of a minority.

Despite your commitment to animals, rodeo events continue, causing abuse and suffering to animals and we've had enough. We've tried everything, and now, we'll see the Government in court.

We're committed to bringing an end to the over 30 rodeo events that are held every summer for the entertainment of a minority. This isn't who we are as New Zealanders, and we will argue in the High Court that it's not legal.

As with our successful challenge in 2020 against the use of farrowing crates and mating stalls for mother pigs, this will not be easy. We will face opposition from all corners and there will be those that say

the lives of these animals don't matter but we will not stop until we have justice for animals abused in rodeo.

Your support of another historic legal action makes a difference. We will keep you posted throughout this process and as we await the assignment of our court date, a day when the voices of animals abused in rodeo will finally be heard.

## **OVER 37,700 PEOPLE** show their love for greyhounds

On 4 August 2021, SAFE and the Greyhound Protection League of New Zealand handed in a petition with over 37,700 signatures calling for a ban on greyhound racing in Aotearoa.

Guest speakers included Green Party MP and Animal Welfare Spokesperson Chlöe Swarbrick and Labour MP Hon Priyanca Radhakrishnan, who accepted the petition on behalf of the Government. We were also joined by several stylish greyhounds wearing a variety of fashionable jackets to keep out the winter chill, accompanied by their passionate greyhound-loving humans and a large crowd of supporters.

With the Government review of the industry now underway, we look to bring this outdated industry to an end. It is time that the Government acknowledges that it is unacceptable that these animals are dying for gambling profits and takes action by implementing an immediate ban on greyhound racing.

Thank you to everyone who signed and shared the petition and travelled from far and wide to join us for this momentous event We couldn't have done it without you!

### **ANIMAL SQUAD** takes action

Earlier this year Animal Squad member Gabrielle Wards was inspired by our Animal Bites newsletter on greyhounds. Gabrielle took action for animals by writing a letter to Prime Minister Rt Hon Jacinda Ardern asking her to ban greyhound racing.

In her letter she wrote, "You should ban greyhound racing because they are forced to run and ... get hurt and it's just not very nice for them."

We were so excited when we heard that Gabrielle received a reply with a handwritten note added to her official letter. Jacinda wrote in her reply to Gabrielle, "I love greyhounds, they're lovely sensitive dogs. I agree we need to look closely on this issue."

It's fantastic to see young people like Gabrielle getting involved and taking action to make the world a better place for animals. She is a real asset to the Animal Squad community – thanks Gabrielle!

#### **CAGE HEN EXPOSÉ**

We have also recently made public the powerful testimony and photographic evidence provided by an anonymous informant from a Northland egg farm. The evidence of the true suffering of hens in colony cage farms was exposed by this courageous person at great risk to their personal safety. The tragic experience of these hens demonstrates the urgent need to free all hens from cages through an immediate ban, further strengthening our case to the Minister of Agriculture, Hon Damien O'Connor.
